FORM-I

- 1.1 `Code No.' is to be filled up by existing contractors for new additional category. New contractors should leave it blank.
- 1.2 Against `FIRM TYPE' please fill as below:

- 1.5 Audited Annual Report for preceding three years are required to be furnished by contractor. In absence of above, the contractor's application is liable for rejection.
- 1.6 Turnover is to be filled showing actual duration as per audited annual report.
- Total Annual Turnover = Total Annual Income from works contracts + Engineering Services + Sales + Closing work in progress - Opening work in progress etc. (Receipt from any other head, whatsoever shall not be considered).
- 1.7 For filling "Net Worth", please calculate as follows :
- NET WORTH = CAPITAL + RESERVES - ACCUMULATED LOSSES.

FORM-II

2.1 For Contractor's previous experience, data supporting documents like copies of work orders, completion certificates, certificate from the clients indicating the awarded value, total executed value, break-up of values (disciplinewise, in case of combination of different disciplines of works), start date, actual completion date, schedule duration, actual duration etc. and performance report in the performa enclosed as Annexure-IV to be furnished.

Further, in case of combination of different disciplines of works executed as part of single contract, Contractor shall indicate executed value of the relevant trade category. This executed value must be supported by a certificate from the client.

2.2 Contractor should give experience details for two largest similar works executed in the last 10 years in each trade category.

2.3 In supervising agency write 'E' for supervision by EIL and 'O' for others.

2.4 For filling 'TRADE CATEGORY' please refer Annexure-II.

2.5 For filling 'Erection Value', please calculate as follows :

ERECTION VALUE = TOTAL VALUE OF WORK - VALUE OF SUPPLY ITEMS AND DESIGN AND ENGINEERING

2.6 In case you are applying for the following Trade Categories, the experience details in terms of Technical Attributes should also be filled-up in applicable TC Format mentioned hereunder for all jobs shown in Form-III.
